VENDOR AGREEMENT

The International Society for Krishna Consciousness ("ISKCON Toronto")

WHEREAS The International Society for Krishna Consciousness operates and delivers *The 52nd Annual Festival of India* ("FOI 2024");

AND WHEREAS the Vendor wishes to participate in *The 52nd Annual Festival of India* and The International Society for Krishna Consciousness wishes to acknowledge such participation;

NOW THEREFORE in consideration of the promises contained herein, the parties agree as follows:

1. Terms & Conditions

The following are the terms and conditions of this agreement (this 'Agreement'). Any breach of these terms or conditions will result in the removal of the vendor from the festival site with no monetary refund.

- 1.1. The Agreement shall be effective as of the date first written above.
- 1.2. The vendor fee is to be paid in full to ISKCON Toronto. The vendor fee is to be paid no later than July 1, 2024. Payments must be made payable by credit card, e-transfer, certified cheque, bank draft or money order (CAD\$), payable to **ISKCON Toronto** and should indicate '**Festival of India 2024 Vendor Fee**' in the memorandum area.
- 1.3. Upon vendor fee payment and application approval by the Festival of India Organizing Committee, no refunds of vendor fees will be issued.
- 1.4. The Vendor is responsible for transporting their own paraphernalia to and from the festival site.
- 1.5. The Vendor is not permitted to take vehicles across to Centre Island unless granted special permission by the Festival of India Organizing Committee in writing at its sole discretion.
- 1.6. The Vendor will be provided with a specified location on the festival grounds to set up their paraphernalia. The Vendor's location will be predetermined by the Festival of India Organizing Committee and are therefore non-negotiable.
- 1.7. The Vendor is not permitted to sub-divide or share their space with another vendor.

- 1.8. Space and tables are provided as stated in the vendor form. The Vendor is **NOT** permitted to bring their own tables to the festival site. The Vendor cannot encroach on another vendor's space, move their assigned booth, or move tables and chairs from other booths.
- 1.9. The Vendor may not distribute promotional materials outside of their designated spot in the vendor area.
- 1.10. The Vendor shall **NOT** bring, consume or sell any alcohol, cigarettes and/or meat products (including eggs) on the festival grounds, as it is contrary to the values of the festival's purpose and is not permitted.
- 1.11. ISKCON Toronto and the Festival Organizing Committee reserve the right at its sole discretion to prohibit any activity involving specific goods and/or services if they conflict with the ethical values and purpose of the festival.
- 1.12. The Vendor is not permitted to sell food or beverages; food or beverages may only be distributed at no charge if authorized in writing by the Festival of India Organizing Committee.
- 1.13. Music is not to be played by the Vendor unless granted approval in writing by the Festival of India Organizing Committee.
- 1.14. ISKCON Toronto and the Festival of India Organizing Committee will not be held accountable for weather, land or water conditions, public health or other government regulations, any act of God or any act beyond their control, which may hinder or prevent the Vendor from proceeding with their involvement at the festival on the terms specified in this Agreement; or which hinders the number of attendees at the festival.
- 1.15. **FOI 2024** does not provide storage space. The Vendor shall not leave any paraphernalia overnight at the festival grounds. Any paraphernalia left unattended shall be done at the Vendor's own risk.
- 1.16. ISKCON Toronto and the Festival Organizing Committee shall not be responsible for any stolen and/or damage of the vendor's property or paraphernalia at any point in time.
- 1.17. The Festival of India committee reserves the right to revise the terms and conditions of this agreement, in which case, the Vendor shall be notified within reasonable time.

Acknowledgement

I acknowledge that I have read and fully understand this agreement, and that I have voluntarily executed the same without inducement or promise not contained herein. I further understand that this agreement may affect my rights and I expressly agree that this agreement shall be construed as broadly as permitted by the law of Province of Ontario and the federal laws of Canada applicable therein, and that if any part hereof is declared invalid, the remainder shall remain in full force and effect to the maximum extent possible. I have read and agree to the above terms and conditions, and will adhere to the Rules and Regulations set forth by ISKCON Toronto and Festival of India. Any dispute arising from this Agreement shall be within the jurisdiction of the courts of Ontario, or settled by arbitration in Ontario, as ISKCON Toronto and Festival of India determine at their sole discretion.

Acknowledgement of Voluntariness

I have not been pressured or coerced in any way to participate in these activities. Any activities I undertake are done so voluntarily and solely for purposes of participating in or attending the above festival or event.

ADDITIONAL GUIDELINES:

In order for both parties to ensure a successful event, the following guidelines should be taken into consideration:

1. The Vendor shall arrive at the festival site for set up no later than **11 am** and no earlier than **9 am** on both days.
2. The Vendor shall be present at the festival grounds, ready for engagement from **12 pm - 8 pm** on Saturday, July 13, 2024 and from **12 pm - 5 pm** on Sunday, July 14, 2024.
3. The Vendor must ensure that their location is left in a clean state upon leaving the festival grounds, or risk revoking the opportunity to participate in future events.
